This petition has been filed by the petitioners to call for the records pertaining to the First Information Report in Crime No288 of 2024 dated 20.12.2024 on the file of the first respondent police, for the offences under Sections 296(b), 191(2), 191(3), 115(2), 118(1) and 351(3) of BNS And Section 4 of TNPPDL Act r/w Section 4 of TNPHW Act and quash the same.

2. When the matter was taken up for hearing, the learned counsels on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

5. Considering the nature of the offences and the relationship between the parties and they have also entered into a compromise, it is appropriate to allow this petition.

6. Recording the said compromise memo, this petition is allowed and the First Information Report in Crime No288 of 2024 dated 20.12.2024 on the file of the first respondent police is quashed.
