ORDER

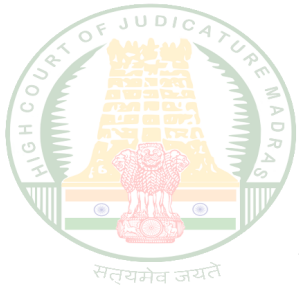

2. The learned counsel for the petitioner would submit that there is a dispute in respect of the mortgage between the petitioner and the third respondent and thereby, he lodged the complaint against the third respondent, on 02.08.2024 before the second respondent, but no action was taken.
