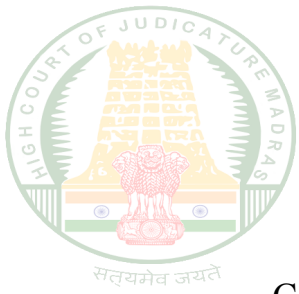

not paid the amount to the Petitioner as per the order of the Writ

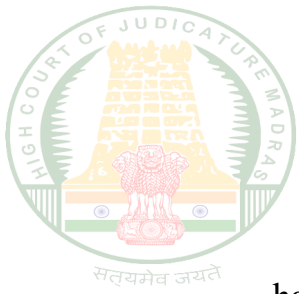

Court, dated 05.14.2019 as well as the assurance given by the Respondents before the Contempt Court on 11.09.2023.

2. This Court heard Ms.Kalpana, the learned counsel for the Petitioner and Mr.D.Sadiq Raja, the learned Additional Government Pleader for the Respondents.
3. Today, the learned Additional Government Pleader for the Respondents has produced a copy of the proceedings, dated 24.12.2024, passed by the 2nd Respondent herein, District Educational Officer, Valliyur, Tirunelveli District and submits that the entire payment had already been made to the Petitioner, as per the judgement and order of the Writ Court, dated 05.04.2019 as well as the order passed by the Contempt Court, dated 11.09.2023. Thus, he further submits that as the payment had already been made to the Petitioner, there is no justification to pass any further order in the present Sub Application and accordingly, the same may be closed.
4. The learned counsel for the Petitioner submits that the Petitioner had already received the entire payment, as per the judgement and order of the Writ Court, dated 05.04.2019 as well as the order passed by the Contempt Court, dated 11.09.2023 and in this regard, the Petitioner
