2.It is the grievance of the petitioner that based on his representation dated 08.12.2023, to remove the encroachments made by the respondents 6 to 12 in S.No.503/5 situated at Vayalimitta, Panaiyur Village Sankarankovil Taluk, Tenkasi, is kept pending till date without any progress. Therefore, he has filed this Writ Petition with the aforesaid prayer.

3.The learned Additional Government Pleader appearing for the respondents 1 to 5 submits that the representation of the petitioner would be considered and appropriate orders would be passed on its own merits within a period that may be stipulated by this Court.

4.Considering the limited scope of the prayer sought for by the petitioner, without expressing any opinion on the merits of the claim made by the petitioner either in the representation or in the affidavit filed in support of this Writ Petition, we direct the respondents 1 to 5 to consider the representation of the petitioner dated 08.12.2023, after giving sufficient opportunity of hearing to the petitioner and the respondents 6 to 12 and pass appropriate orders on merits
