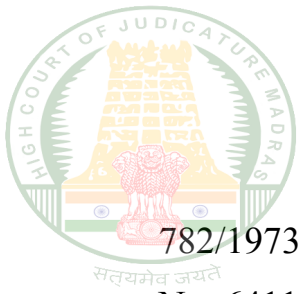

**PRAYER:** Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus, directing the respondents to rectify the extent in the patta and the Filed Measurement Book with respect to petitioner's property measuring extent of 1215 Sq.fts in east Portion which totally comprised in S.No.450/4 measuring extent of about 4.1/6 cents, S.No.450/3 extent of  $\frac{3}{4}$  cents and S.No.450/2 measuring extent of about  $\frac{3}{4}$  cents respectively, situated at Rasingapuram Village, Bodinayakkanur Taluk, Theni District as per the registered documents Viz., Doc.No.782/1973, Doc. No.254/1982, Doc.No.

782/1973, Doc. No. 1317/1985, Doc. No. 1318/1985, Doc. No. 364/1990, Doc. No. 6411/2023 respectively by considering the petitioner's representation, dated 11.11.2024 within a time frame fixed by this Court.

### **ORDER**

The petitioner has sought for issuance of writ of mandamus to direct the respondents to rectify the mistakes in the patta and FMB. The petitioner has made a representation on 11.11.2024.

2. Heard the learned counsel for the petitioner and the learned Special Government Pleader for the respondents.

3. The grievance of the petitioner is that despite passage of several months, no action has been taken on the representation of the petitioner.

4. The learned Special Government Pleader would submit that the petitioner had purchased the property in 2002. Therefore, he would submit that subsequently, survey number has undergone several subdivisions and therefore,

unless the petitioner applies for correlation and correlations certificate is issued,

the necessary follow up rectification of the patta and FMB cannot be carried out.

5. In view of the above, this writ petition is disposed of, directing the petitioner to make an application for correlation of survey number by making appropriate application to the 3<sup>rd</sup> respondent within a period of two (2) weeks from the date of receipt of copy of this order. Once such an application is made by the petitioner, the 3<sup>rd</sup> respondent shall correlate the survey numbers purchased by the petitioner and thereafter, take necessary steps with regard to any rectification in the patta and FMB that may be warranted. The said exercise shall be completed within a period of eight (8) weeks from the date of application for correlation being made, by the petitioner.

6. With the above direction, this Writ Petition stands disposed of. No costs.
