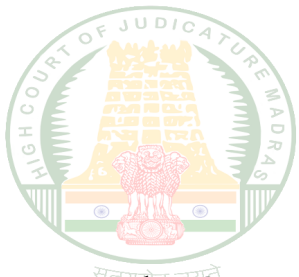

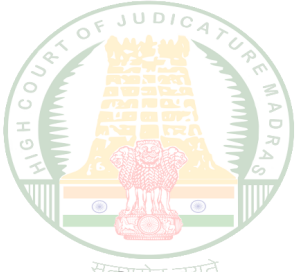
3. Accordingly, this Criminal Original Petition stands dismissed.
