ORDER

2.I have heard Mr.K.Guhan, learned counsel for the petitioner and Mr.B.Saravanan, learned Additional Government Pleader appearing for the second respondent.

3. The petitioner seeks issuance of a Writ of Mandamus to direct the survey to be conducted based on her application dated 21.03.2024. The petitioner basis her claim for survey on a partition deed. It is the case of the petitioner that no notice was given for survey on 29.05.2024. Survey could not be conducted because of the objections of the private respondents namely the third respondent, who is an adjoining neighbouring owner.
