ORDER

The case of the petitioner is that the petitioner's husband was Ex-serviceman, retired from the Indian Army and he was issued with B-memo by the Revenue Authorities recognising his possession. The petitioner's husband passed away and thereafter, the petitioner continues to occupy the said property, in respect of which B-memo was also issued to her husband. The petitioner has made a representation and also issued a lawyer's notice on 17.02.2023 for assignment of patta in her favour and the petitioner only seeks for disposal of the said application.

2. However, the learned Additional Government Pleader appearing for the respondents would submit that there is a proposal to construct a ITI College in the said locality and therefore, the authorities would consider the petitioner's application on merits and pass orders.
