4. Being satisfied with the reason stated in the petition, this Court is inclined to modify Condition No.2 of the bail order in Cr.M.P.No.504 of 2025 dated 24.01.2025 passed by the learned Judicial Magistrate No.5, Trichy, as follows:

“The petitioner shall appear and sign before the respondent Police weekly thrice (ie., on Monday, Tuesday and Wednesday) at 10.00 a.m., until further orders.”

5. Accordingly, this Criminal Original Petition stands allowed. The other conditions shall hold good.
