originally the convict was retained at Central Prison, Coimbatore and later, he was temporarily transferred to Central Prison, Madurai. Now the Director General of Prison, Chennai, vide communication dated 14.05.2025 in No.3043/प्र.2/2025, has directed the petitioner to be retained permanently in Central Prison, Madurai and thereby nothing survives for further adjudication.

4.Recording the submission made by the learned Additional Public Prosecutor, this Writ Petition stands closed as infructuous. No costs.
