Heard Mr.N.Senthilnathan, learned counsel appearing for the petitioner, Mr.P.Thilak Kumar, learned Government Pleader for the respondents.

2.The contention of the petitioner is that in Ilayangudi Government Hospital, there are no sufficient staff strength. When the people around Ilayangudi approach the hospital, they were told that the Doctors are unavailable. Hence, the people in that locality are put to great hardship. Hence, the petitioner made a detailed representation to the respondents to fill up the vacancies in the Government Hospital. Since the same was not considered, the petitioner has filed this present writ petition.
