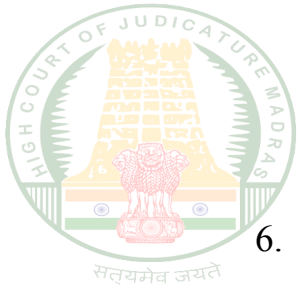

4. The learned Government Advocate would submit that the application of the petitioner is now pending with the Revenue Divisional Officer, Tirunelveli and the Revenue Divisional Officer has also commenced necessary enquiry proceedings.

Considering the above, this writ petition is disposed of, directing the Revenue Divisional Officer, Tirunelveli to conduct an enquiry, after affording an opportunity to the petitioner as well as the 7th respondent and pass final orders within a period of four (4) weeks from the date of receipt of copy of this order. Till such time the Revenue Divisional Officer, Tirunelveli takes a final decision, the town survey shall be kept in abeyance.
