This Writ Petition is filed seeking for a direction to the respondents 1 to 4 to remove the illegal encroachments made by the respondents 5 to 8 in Survey No.310/11 situated at Sivarakkottai Village, Kalligudi Taluk, Madurai District.

2.The learned Government Advocate, appearing for the respondents 1 to 4, based on the written instructions from the Tahsildar, Kalligudi, dated 26.08.2025, submitted that a survey has been scheduled to be held on 28.08.2025. After completion of the survey, encroachments, if found, will be identified and appropriate action will be initiated in accordance with the provisions of the Tamil Nadu Land Encroachment Act, 1905 and the relevant rules within the time stipulated by this Court.

3.In view of the submissions made, the official respondents are directed to complete the survey and take appropriate enforcement action
