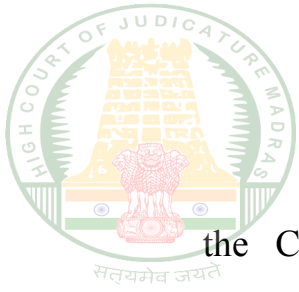
ORDER

This petition has been filed by the petitioner to call for the records pertaining to C.C.No.752 of 2024 pending on the file of the learned Judicial Magistrate No.VI, Madurai for the offences under Section 381 of IPC, in Crime No.688 of 2023 and quash the same.

2. According to the petitioner, due to the money dispute, the defacto complainant lodged a complaint against the petitioner. Based on the complaint given by the defacto complainant, the police has registered FIR in Cr.No. 688 of 2023 for the offences under Section 381 of IPC.

3. When the matter was taken up for hearing, the learned counsel on both sides represented that during pendency of the case in C.C.No.752 of 2024, the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

4. Today, the defacto-complainant and the accused are present and

6. Considering the nature of the offences and the parties have also entered into a compromise, it is appropriate to allow this petition.

7. Recording the said compromise memo, this petition is allowed and C.C.No.752 of 2024 pending on the file of the learned Judicial Magistrate No.VI, Madurai, is quashed as against this petitioner.
