PRAYER:- Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified mandamus calling for the records from the respondents relating to the impugned orders of suspension passed by the fourth respondent dated 1.3.2023 and further extension of orders of suspension passed by first respondent dated 28.08.2023 and 27.11.2023 and to quash the same and consequently direct the respondents to reinstate the petitioner into service and to pass consequential service benefits and monetary benefits like back wages including arrears of subsistence allowances within the reasonable time.
