and 5.00 pm until further orders. The other conditions shall hold good.

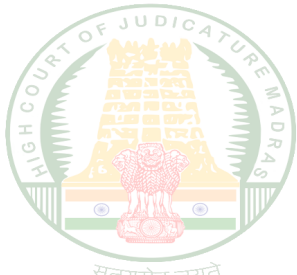
