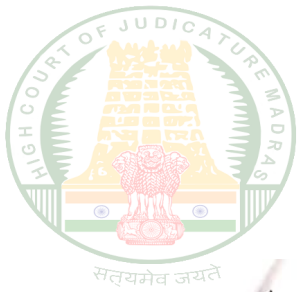

SETTLEMENT AGREEMENT

This SETTLEMENT AGREEMENT entered into on 16.06.2025 between

M. Suresh kumar

and

P. Gandhi

Whereas

1. Disputes and differences had arisen between the parties hereto and CRL.OP(MD) No. 5865 of 2025 filed on 26.03.2025 before the Hon'ble Madurai Bench of Madras High Court.

2. The matter was referred to Mediation/Conciliation vide an order dated 03.04.2025 passed by the Hon'ble Mr. Justice. R. Sakthivel

3. The parties agreed that Mr.V. Maharajan and Mr. T.J. Ebinezer charles would act as their Mediator/Conciliator.

4. Several meetings were held during the process of Mediation/Conciliation on 16.04.2025 to 16.06.2025 and the parties have with the assistance of the Mediator/Conciliator voluntarily arrived at an amicable solution resolving the above mentioned disputes and differences.

5. The parties hereto confirm and declare that they have voluntarily and of their own free will arrived at this settlement agreement in the presence of the Mediator/Conciliator.

The petitioner has agreed to settle the matter in the absence of his counsel. P. Gandhi

6. The Following settlement has been arrived in between the parties hereto

- A. On 29.04.2025 the petitioner/Accused-A3 to settle Rs.20 lakhs (Twenty lakhs) to the defacto complainant (intervenor namely R.Ganthi). As he agreed, he settled Rs. 20 lakhs on 12/06/2025 through RTGS, HDFC Bank.
- B. On 29.04.2025 the defacto complainant/intervenor agreed to co-operate to the petitioner to cancel the sale deed registered in DOC.No. 4088/2021 dated 06.08.2021. As he agreed, the (defacto complainant) cancelled the said agreement on 12.06.2025 in DOC.No. 3612/2025. The matter was settled between parties.
- C. The defacto complainant agreed to withdraw his complaint in Cr.No. 9/2025, on the file of central crime Branch, Madurai.

7. By signing this Agreement the parties hereto state that they have no further claims or demands against each other with respect to CRL.OP.(MD)No. 5865/2025 and all disputes and differences in this regard have been amicably settled by the parties hereto through the process of Mediation
