extension of time will be granted.

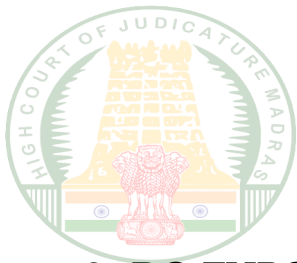
