ORDER

This petition has been filed by the petitioners/Accused Nos.1 to 3 to call for the records pertaining to the First Information Report in Crime No. 362 of 2017 dated 27.09.2017 on the file of the first respondent police, for the offences under Sections 294(b), 324 and 506(2) of IPC and quash the same.
