ORDER

This Writ Petition has been filed seeking a Writ of Mandamus, directing the respondents 1, 2 & 3 to settle my surrender leave salary so far not given by the respondent Corporation for 62 days for the value of Rs.45,147.00 (Rupees Forty five thousand One Hundred and forty Seven only) in respect of the years 2011 to 2023 together with interest at the rate of 18 % per annum payable from the date for retirement to till the date of actual payment.

2. A perusal of the records reveal that the petitioner had attained superannuation on 31.05.2023. However, his surrender leave salary was not paid, due to paucity of fund. The petitioner has sent a representation on 25.03.2025, seeking the above said benefits. So far, there is no response from the authorities, the present writ petition has been filed.
