ORDER

This Writ Petition has been filed seeking a direction to the first respondent to implead the petitioner's grandfather's name, namely Sivasankaralinga Pandia Chinnaiyasamy Nayacker, in the death certificate of his grandmother, namely Jameentharani @ Bangarammal in the column relating to the husband's name and to issue the same to the petitioner, based on his representation dated 15.03.2023.
