This Criminal Original Petition has been filed to direct the 2nd respondent not to interfere in the civil dispute and not to harass the petitioner and his family members in the guise of enquiry.

2. According to the Petitioner, based on the complaint lodged by the 3rd Respondent in respect of money dispute, the 2nd Respondent frequently, called the Petitioner for enquiry. Therefore, this petition has been filed.

3. The learned Additional Public Prosecutor appearing for the respondent police would submit that based on the complaint of the 3rd Respondent in respect of job racketeering, they have called the Petitioner for enquiry and now, the enquiry is closed. Therefore, nothing survives for further adjudication.

4. Considering the limited scope of the prayer sought for in this petition, this Court, without even issuing notice to the private respondent, is inclined to pass orders.
