Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents 1 to 4 to remove the encroachment made by the respondents 5 to 8 in pathway in S.F.No.293/10B, 11, 12 of Vittalpatti Village, Peraiyur Taluk, Madurai District and the encroachment in the water body S.F.No.291/10 of Vittalpatti Village, Peraiyur Taluk, Madurai District.

ORDER

The scope of this writ petition stands confined to S.No.219/10 of Vittalpatti Village alone. We grant liberty to the petitioner to pursue his remedy independently in respect of the other survey numbers mentioned in the writ prayer.

2.S.F.No.219/10 has been classified as “Oorani”. The petitioner seeks removal of the encroachments committed thereon.

3.The learned Government Advocate also confirms the character of the said survey number as water body.
