2. The Learned Government Advocate appearing for the official respondents submitted that permission has already been granted by the respondents, and therefore, nothing survives for adjudication.

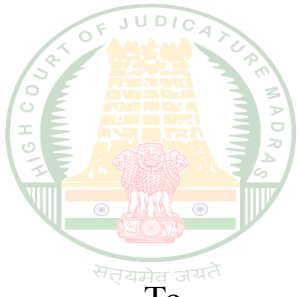
3. Recording the aforesaid submission, this Writ Petition is closed.
