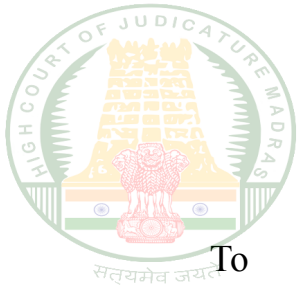
When the cases are taken up for hearing, the learned Additional Government Pleader would submit that the orders sought to be reviewed has been complied with by the authorities.
