The present Writ Petition has been filed for the issuance of a Writ of Mandamus, to consider the petitioner's representation dated 20.05.2022.

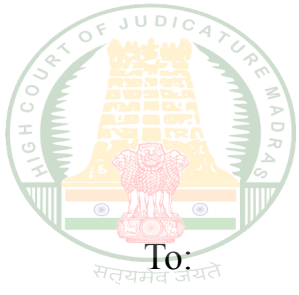
