This petition has been filed by the petitioners to call for the records pertaining to the First Information Report in Crime No.715 of 2023 dated 24.12.2023, on the file of the first respondent police, for the offences under Sections 341, 294(b), 323, 506(i) and 379 of IPC and quash the same.

2. When the matter was taken up for hearing, the learned counsel on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

3. The defacto-complainant and all the accused are present and this Court enquired about the terms of compromise. The defacto-complainant represented that they entered into a compromise and has no objection to

quash the FIR. A compromise memo, dated 15.03.2024 signed by the parties and their respective counsel, is also filed before this Court.

6. Recording the said compromise memo, this petition is allowed and the First Information Report in Crime No.715 of 2023 dated 24.12.2023 on the file of the first respondent police is quashed. The compromise memo dated 15.03.2024 filed by the parties shall form part of this order.
