ORDER

This Writ Petition has been filed seeking a writ of mandamus directing the respondents to settle interest at the rate of 6% per annum for the belated payment of the petitioner's husband Late V.Manikandan terminal benefits including Provident Fund, Gratuity and Leave Salary from the date of his death i.e., from 07.04.2023 to till the date on which the said benefits were settled to her.

2. The petitioner's husband was appointed as Conductor in the first respondent Corporation on 18.12.1992 and he died on 07.04.2023 while in service. The learned counsel for the petitioner submits that the petitioner's husband's terminal benefits was not settled immediately and there is an abnormal delay.

3. In view of the same, the only issue to be considered in this Writ Petition is with regard to interest payable on the belated settlement. This issue was dealt with by this Court on various occasions and this Court passed orders in several Writ Petitions. In fact, the issue involved in this writ petition is no longer *res-integra*.

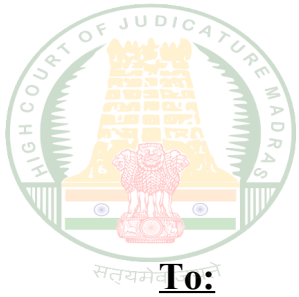
5. Accordingly, by following the order stated supra, this Writ Petition is allowed with the following direction:

The respondents shall pay interest to the petitioner at the rate of 6% per annum on the belated payment of the retirement benefits commencing from the date of the petitioner's husband death, till the date of actual disbursement, within a period of three months from the date of receipt of a copy of this order.
