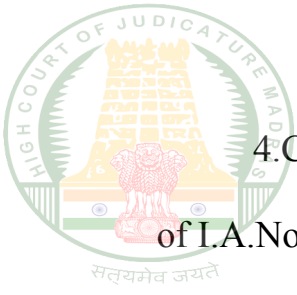

ORDER

The defendants 1 and 2 in O.S.No.284 of 2004, on the file of the Additional District Court, Dindigul, have filed the present revision petition seeking expeditious disposal of I.A.No.137 of 2020, which was filed for passing of final decree in a suit for partition.

2.A perusal of the records reveal that the defendants 1 and 2 have filed I.A.No.137 of 2020, for passing of final decree with regard to A, B, D, E and F schedule properties.

3.A perusal of "B" diary extract reveals that the petitioners herein have filed I.A.No.9 of 2024, under Order 6 Rule 17 of C.P.C. to implead the legal heirs of the deceased 8th respondent. Due to pendency of the same, the final decree application has not been taken up for final hearing.



4.Considering the above said facts, the trial Court is directed to dispose of I.A.No.137 of 2020, on or before **31.08.2025.**
