ORDER

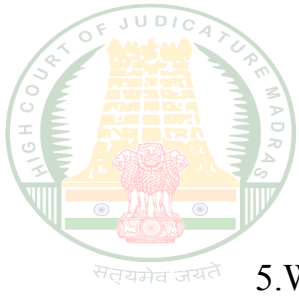

The present writ petition has been filed challenging the order of the first respondent who is the original authority under the Payment of Gratuity Act, 1972. The said order has been passed on 24.10.2024.

2.As against the order of the first respondent, a statutory appeal remedy is available under Section 7(7) of the Payment of Gratuity Act, 1972. In such circumstances, this Court is not inclined to entertain the present writ petition.

3.The period spent between 07.04.2025, till the date of receipt of a copy of this order from this Court shall be excluded, in case if an appeal is preferred before the appellate authority. The appeal shall be disposed of within a period of 3 (three) months from the date of filing of the appeal.

4.The name of the petitioner Panchayat has been wrongly mentioned as Santhampattai Village Panchayat. However, the correct name of the Panchayat is Sendurai Village Panchayat.
