COMMON ORDER : The Court made the following common order :-

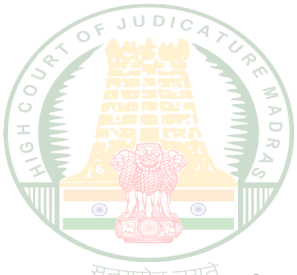

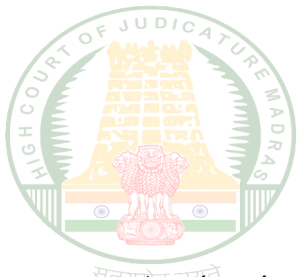
