2.Heard the learned counsel for the petitioner and the learned counsel for the third respondent.

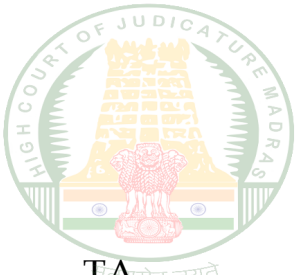
