Since the matter is *sub judice* in A.S.No.65 of 2019 on the file of III Additional District Court, Tirunelveli, the impugned order cannot be given effect to till such time as the finality arrived in A.S.No.65 of 2019. It is needless to state that subject to the ultimate result of A.S.No.65 of

2019, it is open to the petitioner to revive his request to challenge the impugned orders.
