ORDER

This Writ Petition is filed for issuance of a Writ of Mandamus directing the respondents to not to proceed the construction of road.

2. Based on this prayer, a survey was conducted, and the petitioner was satisfied with the outcome, which indicated that the land belongs to the Thiruvavaduthurai Athinam. Since an objection was raised by Highways, a re-survey was conducted by measuring the land from boundary stone to boundary stone. After this measurement, the petitioner was also satisfied with the boundaries marked.

3. However, prior to the re-survey, the respondents had already cleared a portion of the Adheenam's land. Therefore, the respondents are strictly directed to lay the road only within the limits of the National Highway, excluding the Thiruvavaduthurai Adheenam's land, based on the second survey report. If

there is any uneven land, the same shall be rectified.
