WEB COPY ORDER: The Court made the following order :-

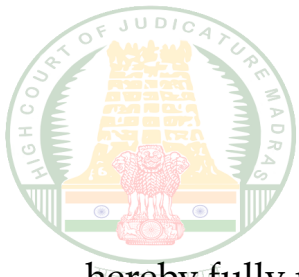
This Petition has been filed to relax the condition imposed in the order passed by this Court dated 26.02.2025 in CrI.OP(MD) No. 3666/2025
