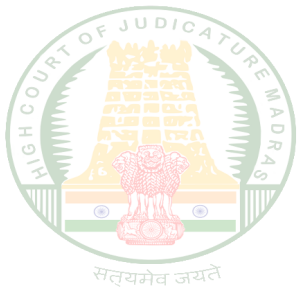

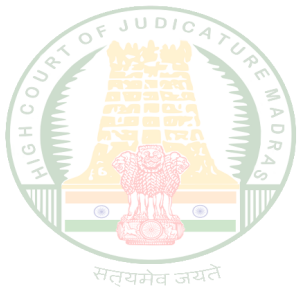

4. This Contempt Petition is closed.

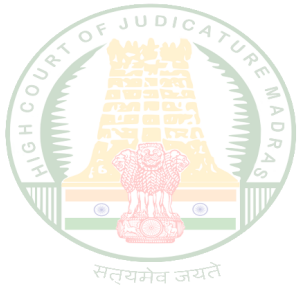
