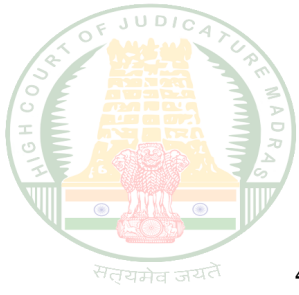
ORDER

2.
