WEB COPY ORDER: The Court made the following order :-

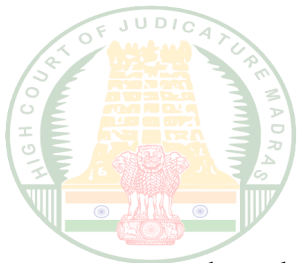
