ORDER

This petition has been filed by the petitioner to call for the records pertaining to the First Information Report in Crime No.3 of 2025 dated 14.02.2025 on the file of the first respondent police, for the offences under Sections 75(1)(ii), 75(2) and 78 of BNS, Section 4 of TN Prohibition of Harassment of Women Act, 2002 and Section 67 of Information Technology (Amendment) Act, 2008 and quash the same.

2. When the matter was taken up for hearing, the learned counsel on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.
