WEB COPY ORDER: The Court made the following order :-

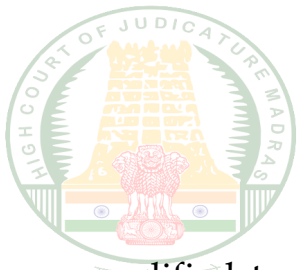
This Petition has been filed to relax the condition imposed in the order passed by this Court in Crl.O.P.(MD).No.4176 of 2025 dated 13.03.2025.
