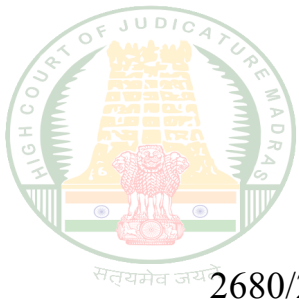

When the matter was taken up for hearing, the learned Additional Government Pleader, appearing on behalf of respondents 1 and 3, submitted, on instructions, that the very same issue has already been decided by this Court in W.P. (MD) No.1774 of 2025, dated 23.01.2025. It was further submitted that the petitioner's name has in fact
