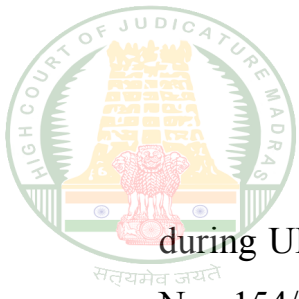

ORDER

The petitioner consequently seeks issuance of patta in the name of Naatamai Uzhiyam in respect of Survey Nos.154/4 (6.85 acres) and Survey No.155/9 (1.24 acres) in Malayakoundanpatti Village, Nilakottai, Dindigul District.

2. Heard the learned counsel for the petitioner and the learned Special Government Pleader for the official respondents.

3. Considering the fact that the petitioner only seeks consideration of his representation for correction of UDR records, this writ petition is disposed of,
