ORDER

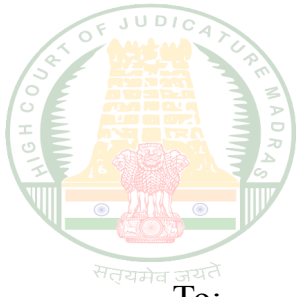
