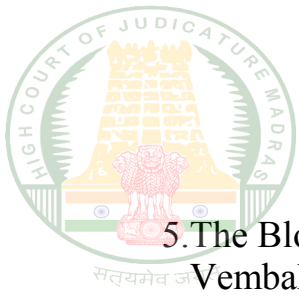

PRAYER in W.P.(MD)No.10909 of 2020: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents 1 and 2 to initiate appropriate action against the concerned authorities in respect of misappropriation of funds, which are allocated under the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 based on the petitioner's representation dated 03.06.2020 and consequently, to direct entrust the investigation with Central Bureau of Investigation in the interest of justice.

PRAYER in W.P.(MD)No.5176 of 2021: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents 1 and 2 to register a case under Prevention of Corruption Act after following the procedures contemplated under Section 17(A) of Prevention of Corruption Act and conclude the same within a stipulated time frame fixed by this Court based on the petitioner's representation dated 03.06.2020.

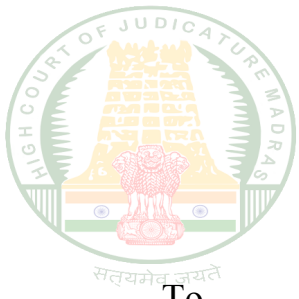
2.In view of the said submission, no further adjudication is required.
