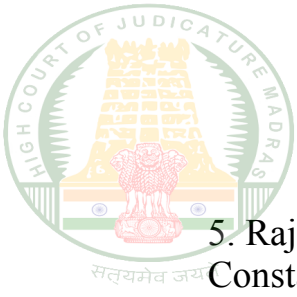

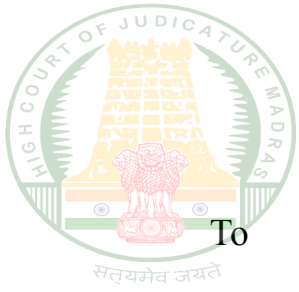
3. Today, a copy of the closure report was also served to the learned Counsel for the petitioner.
