This Criminal Original Petition has been filed seeking a direction to the learned Judicial Magistrate, Eraniel, Kanyakumari District, to dispose of the case in C.C.No.141 of 2023 as expeditiously as possible.

2.According to the petitioner, based on the complaint lodged by the second respondent, an FIR in Crime No.116 of 2015 was registered for the offence under Section 387 of IPC. After completion of investigation, the respondent police filed final report before the learned Judicial Magistrate, Eraniel, Kanyakumari District and the same was taken cognizance in C.C.No.141 of 2023.
