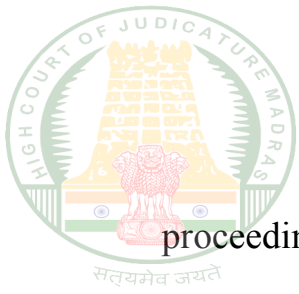
By consent, this writ petition is taken up for final disposal at the admission stage itself.

2.Heard Mr.Adithya Varadarajan, learned counsel for the petitioner and Mr.K.Govindarajan, learned Deputy Solicitor General of India for the respondents 1 to 3, Mr.K.P.Krishna Doss, learned Standing Counsel for the fourth respondent and Mr.P.Thilak Kumar, learned Government Pleader for the respondent Nos.5, 6 and 7.

3.The writ petition was filed seeking a direction to the respondents to construct an underpass in the Madurai ring road to enable expansion of runway of Madurai Airport by considering the petitioner's representation dated.28.10.2024.
