2.The learned counsel appearing for the petitioner would submit that the people in the village decided to conduct Varushabishekam in Arulmigu Valamburi Vinayagar, Arulmigu Periyanaagagi Amman and Arulmigu Singamuga Mariamman Thirukovil on 25.04.2025 and 26.04.2025 for that the petitioner has sent a representation dated 07.04.2025 but the same has not been considered, hence the present petition has been filed.

3. The learned Government Advocate appearing for the respondents 1 and 3 would submit that there is no dispute in respect of conducting festival in the village and thereby police protection can be granted.

4. The learned Additional Public Prosecutor appearing for the respondents 2 and 4 would submit that for conduct of festival they will give police protection in accordance with law.
