This Criminal Original Petition has been filed to direct the respondents herein to expedite the investigation and to include the petitioner's name in the list of Victims/Depositors/Witness in Cr.No. 3/2023 on the file of the 2nd respondent police based on the petitioner's complaint dated 03.03.2025 and record the statement under Section 161(3) Cr.P.C.

2.According to the petitioner, based on the complaint given by one of the victim, the case has been registered by the 2nd respondent police. He is also one of the victim in Cr.No.3 of 2023. Therefore, his name has to be impleaded as one of the victim in this case. In this regard, he has sent a representation to the respondent police on 03.03.2025 and the same has not been considered. 4.Considering the limited scope of the prayer sought for by the petitioner and the representation of the petitioner is pending with the 2nd respondent, this Court hereby direct the 2nd respondent to consider the complaint of the petitioner and take appropriate action in accordance with law within a period of 15 days from the date of this order, in accordance with law.

5.With the above direction, this Criminal Original Petition stands disposed of.
