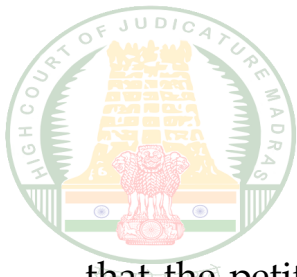
PRAYER :-

4. Considering the facts and circumstances of the case, this Court is inclined to modify the condition imposed on the petitioner in the said Criminal Original Petition.

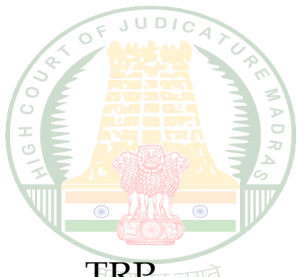
